PennVEST Holds Public Meeting On Intended Use Plan for Federal Stimulus Money - Apr 1

The PA Infrastructure Investment Authority will hold a public meeting on April 1 on the intended use plans for the additional water infrastructure funding made available by the American Recovery and Reinvestment Act. Less Nitrogen Could Increase Profit, Sustainability

ScienceDaily (Mar. 7, 2009) — More fertilizer doesn't always mean more profit. That's one conclusion from a 10-year study conducted by Agricultural Research Service (ARS) scientists at the agency's Soil Plant Nutrient Research Unit in Fort Collins, Colo., and colleagues at Colorado State University. From 1998 to 2008, the researchers evaluated and compared potential management strategies for reducing nitrogen and nitrate nitrogen levels in soil and groundwater. The research, led by ARS soil scientist Ardell Halvorson, focused on irrigated cropping systems in the Arkansas River Valley, an agricultural region of Colorado that has high levels of nitrate nitrogen in the fields and groundwater—due, in part, to heavy application of nitrogen fertilizer and the prevalence of shallow-rooted crops such as onions. The first study showed that onions used only about 12 to 15 percent of the fertilizer nitrogen applied to the crop. Much of the remainder stayed in the top six feet of soil. The next year, Halvorson and his colleagues planted corn on the same land and found that it recovered about 24 percent of the fertilizer nitrogen that had been applied to the onion crop. Following that study, the scientists grew alfalfa on the land for five years, then followed it with a watermelon crop, followed by a corn crop. In the first year that the corn was grown, an unfertilized control plot yielded about

250 bushels of corn. By comparison, a plot fertilized with 250 pounds of nitrogen per acre yielded about 260 bushels, a small increase that required a significantly higher investment of time and money. Additional corn studies following onion in rotation showed corn was a good residual nitrogen scavenger crop. The results suggest that when managing fields with relatively high nitrogen levels, farmers could benefit economically from reduced nitrogen fertilization rates. Recommendations based on this research could have important economic and environmental benefits for the Arkansas River Valley and similar regions. Nutrient Pollution Chokes Marine and Freshwater Ecosystems

ScienceDaily (Mar. 5, 2009) — Protecting drinking water and preventing harmful coastal "dead zones", as well as eutrophication in many lakes, will require reducing both nitrogen and phosphorus pollution. Because streams and rivers are conduits to the sea, management strategies should be implemented along the land-to-ocean continuum. In most cases, strategies that focus only on one nutrient will fail. These policy recommendations were put forth by a team of distinguished scientists in the recent issue of Science, published February 20. Led by Dr. Daniel J. Conley, a marine ecologist at the GeoBiosphere Science Centre in Sweden and a Visiting Scientist at the Cary Institute of Ecosystem Studies, the paper reviews weaknesses in single-nutrient management strategies. In most cases, improving water quality and preserving coastal oceans will require a two-pronged approach. Plant growth is tied to nitrogen and phosphorus availability. Human activities have greatly increased the abundance of these nutrients, causing the overproduction of aquatic plants and algae. Nitrogen pollution is largely derived from agricultural fertilizers and emissions from the combustion of fossil fuels. Phosphorus pollution is tied primarily to wastewater treatment and detergents. Inputs to the landscape make their way to coastal areas through the drainage networks of rivers and streams. Eutrophication is a problem of global concern. Worldwide, there are over 415 eutrophic coastal ecosystems. As a result of human population growth and increased pollution, this number continues to rise. The paper's authors included: Drs. Daniel J. Surface Water Contaminated With Salmonella: More Common than Thought

ScienceDaily (Feb. 27, 2009) — A new University of Georgia study suggests that health agencies investigating Salmonella illnesses should consider untreated surface water as a possible source of contamination. Researchers, whose results appear in the March issue of the journal Applied and Environmental Microbiology, tested water over a one-year period in rivers and streams in a region of South Georgia known for its high rate of sporadic salmonella cases. The team found Salmonella in 79 percent of water samples, with the highest concentrations and the greatest diversity of strains in the summer and after rainfall. The team studied streams in the upper reaches of the Suwannee River Basin, which begins in South Georgia and flows into central Florida. The study area contains a mix of forested lands, row crops, pasturelands, wetlands and small cities. The researchers chose sampling sites near a variety of those environments but found little variation in Salmonella concentrations by location. The diversity of Salmonella strains, however, was highest near a farm containing cattle and a pivot irrigation system, suggesting that close proximity to livestock and agriculture increase the risk of contamination. The researchers also found a strong and direct correlation between rainfall for the two days preceding sample collection and the concentration of Salmonella, suggesting that runoff contributes to the contamination. Residential Development Shifts Toward Urban Centers

In a fundamental real-estate-market shift toward smart growth, urban core communities in half of the nation's 50 largest metropolitan areas have dramatically increased their numbers and regional shares of new residential building permits since 2000 – a socioeconomic recovery credited mainly to less crime, changed demographics and strong demand for housing in walkable neighborhoods near high-paying jobs, reports the U.S. EPA in a quantitative "Residential Construction Trends in America's Metropolitan Regions" study, conducted in the Development, Community, and Environment Division (DCED) and based on Census Bureau data for the 18-year period of 1990-2007. http://www.smartgrowth.org/news/article.asp?art=7014&state=52

Pervious Pavements - New findings about their functionality and performance in cold climates

Widespread misconception exists in the industry about pervious pavement systems, specifically about their functionality in cold-weather environments. The prevalent belief is that pervious pavements are not an effective stormwater management option for cold-weather climates because of concerns related to diminished permeability during freezing and that the material is not durable enough to withstand freeze-thaw conditions. Cold climates are typically very hard on constructed systems, and naturally, questions should arise about the effectiveness of pervious pavements in these environments—especially due to concerns about freezing of the filter media. However, according to Dr. Robert Roseen, director of the University Of New Hampshire Stormwater Center (UNHSC), stormwater management systems using infiltration and filtration mechanisms, if properly designed, can work well in cold-weather environments. He has been leading a four-year research effort focused on monitoring the year-round performance of a porous asphalt placement that was installed on the UNH campus. In addition, the UNHSC is hoping to shed light on the functionality of pervious concrete by testing a large placement that was also installed on the university campus in August 2007—the first major pervious concrete parking facility in New England. The purpose and function of the UNHSC is to evaluate the range of stormwater treatments systems available to designers, including proprietary and nonproprietary systems. The UNHSC is funded by the Cooperative Institute for Coastal and Estuarine Environmental Technology and the National Oceanic and Atmospheric Administration. Findings from the porous asphalt study have demonstrated functionality that exceeds conventional practices by measures of both water quality and hydraulics. Cleaning contaminated water - with Vinegar

Leeds, United Kingdom – Engineers and environmental scientists at the University of Leeds are developing methods of helping contaminated water to clean itself by adding simple organic chemicals such as vinegar. The harmful chromium compounds found in the groundwater at sites receiving waste from former textiles factories, smelters, and tanneries have been linked to cancer, and excessive exposure can lead to problems with the kidneys, liver, lungs and skin. The research team, led by Dr Doug Stewart from the School of Civil Engineering and Dr Ian Burke from the School of Earth and Environment, has discovered that adding dilute acetic acid (vinegar) to the affected site stimulates the growth of naturally-occurring bacteria by providing an attractive food source. In turn, these bacteria then cleanse the affected area by altering the chemical make-up of the chromium compounds to make them harmless. Chromate chemicals have previously been successfully treated in situ in neutral pH conditions, but this study is unique in that it concentrates on extremely alkaline conditions, which are potentially much more difficult to treat. The current favored method of dealing with such groundwater contaminants is to remove the soil to landfill, which can be costly, both financially and in terms of energy usage. The Leeds methods being developed will allow treatment to take place on site, which is safer, more energy efficient and much cheaper.
