Official Food Vendor Contract

- *This is a street fair with no electrical provisions & Vendors are responsible for their own set up (i.e. canopy, tables, chairs, etc.).
- * **No refunds for any reason except event cancellation.**
- *This is a family event; products of an adult nature are not permitted.
- *The coordinators of this event are not responsible for any accidents, damage or theft.
- * **The event is held on Greenbriar Lane between North Baltimore Street & Harrisburg Pike. Vendors MUST enter Greenbriar from Baltimore Street/Rte. 74 S and exit on to Harrisburg Pike.**
- * Set up will begin at 6:00 am, all vendors are required to be in place and all vehicles removed from the street by 7:45am. One lane of traffic must remain open at all times during setup. While unloading please keep any vehicles off to the side so that a thorough fare remains open for any emergency vehicles.
- *Vendors are required to remain in place until 3:00 pm unless otherwise directed by the organizers. NO VEHICLES will be permitted back onto the street until the pedestrians have dispersed and deemed safe by the coordinators. One lane of traffic must remain open at all times during tear down. While loading please keep any vehicles off to the side so that a thorough fare remains open for any emergency vehicles.
- *Directions: **From Gettysburg** on Route 15 – at second light, turn right at the PNC Bank to south-bound Route 74. Proceed 500 feet and turn left onto Greenbriar Ln. **From Harrisburg** on Route 15 – at the third light turn left at the PNC Bank to pick up south bound Route 74. Proceed 500 feet and turn left onto Greenbriar Ln. **From York** on Route 74 – travel ¼ mile past the traffic light at the Dillsburg town square then turn right onto Greenbriar Lane. **From Carlisle** on Route 74 – turn right at the light at Shumaker’s Getty Station onto Rt15. Travel about ¼ mile to left turn at the PNC Bank, following south-bound Route 74. Proceed 500 feet and turn left onto Greenbriar Lane.
- *As a food vendor you are required to have all licensing and insurances as required by the state. Please provide proof of both.
- *You are responsible for cleaning your area. There is to be no dumping of any liquids. Area will be inspected before you leave to assure no grease or other debris has been left.
- *Menu items must be approved by the coordinators of this event.
- *As a food vendor you agree to pay 25% of all money received back to the coordinators of the event. See below **
