INSPECTIONS

It shall be unlawful for any person to construct any building and/or structure within the limits of Dillsburg Borough, York County, Pennsylvania, without first obtaining a building permit to do so hereinafter provided.

No building permit shall be issued unless an application is made to the Building Code Official of Dillsburg Borough, signed by the owner or by a duly authorized agent or contractor, if any. The application shall contain such information as is required by the Building Permit.

It will be the duty of the permittee to see that the permit is posted in a conspicuous place where the work is being performed and that it is maintained thereon until a completion certificate has been filed.

Any permit issued shall become invalid if the authorized work is not commenced within six (6) months after issuance of the permit, or if the authorized work is suspended or abandoned for a period of six (6) months after the time of commencing of work. All work must be completed within twelve (12) months of issuance of permit.

The Owner or Contractor must file within thirty (30) days from the completion of the work, with the Building Code Official..
