RE-ORGANIZATIONAL MEETING
JANUARY 3, 2012
MINUTES

The Dillsburg Borough Council held their re-organizational meeting at the Borough Office on the above-mentioned date. Council Members attending were: Jeff Griffin, Holly Kelley, John Richardson, Dave Baldwin, Hal Anderson, Yvonne Laukemann and Matt Fawber. Also present were Borough Manager Karen Deibler, District Judge Richard Thomas, Mayor Hank Snyder and Tax Collector Debbi Beitzel.

The following visitors were present: Mark Ryder and Jeff Beitzel.

The meeting was called to order by Mayor Hank Snyder at 6:08 PM, followed by the Pledge of Allegiance to the flag and an invocation given by the Mayor.

OATHS OF OFFICE

District Judge Thomas administered the Oaths of Office to the reelected Council Members, Jeffrey Griffin and David Baldwin, newly elected Tax Collector, Debbi Beitzel and newly elected Council Member, Yvonne Laukemann. District Judge Thomas noted there were two copies of the Oaths; one to be filed and one for each individual.

ELECTION OF PRESIDENT

ELECTION OF VICE PRESIDENT

ELECTION OF PRESIDENT PRO TEM

Vice President Kelley nominated John Richardson for President Pro Tem. Nomination seconded by Council Member Fawber. There were no other nominations for

President Pro Tem. The nomination for John Richardson for President Pro Tem was approved.

COMMITTEE ASSIGNMENTS and OTHER APPOINTMENTS

President Griffin noted the Dillsburg Borough Council Members are members of the Public Safety Committee, the Public Works Committee, or the Administrative Committee.

Council Members Baldwin and Richardson will remain on Public Safety. Council Members Anderson and Fawber will remain on Public Works. Council Member Kelley will remain on Admin, along with Council Member Laukemann. Vice President Kelley, Council Member Richardson and Council Member Anderson will be the Chairs of their appointed Committees.

President Griffin nominated Debbi Beitzel for Borough Secretary. Nomination seconded by Council Member Richardson. There were no other nominations for Borough Secretary. The nomination for Debbi Beitzel for Borough Secretary was approved.

Council Member David Baldwin nominated Karen Deibler for Borough Treasurer. Nomination seconded by Council Member John Richardson. There were no other nominations for Treasurer. The nomination for Borough Treasurer was approved.
