**Old Business:**

**Walking/Recreation Path:**

The money is coming in for our part of the matching funds. A motion was made and passed to submit the path for bidding two ways: first, the original shortened path and second, with an extension along the barn side. Any parts of the path that are done now can always be added onto in the future to make a longer path. It was decided to go ahead and put the path out to bid now, knowing that the work at Chestnut Park should be close to completion by the time the bid process is done so that it can be reviewed for quality.

Other options for funding are: Elmcroft (wanted a short presentation), DABA (a letter is going to be presented at their next meeting), Kiwanis (Jim is going to attend their breakfast), Lobar & DYB (both had letters sent to them)

**Barn Lighting:**

No further complaints have been received. Bob will continue to monitor the situation.

**Tree Donations:**

The trees are Red Maples and sites were selected around the baseball field so that some shade would be supplied to game watchers.

**Fence Damage:**

A claim has been submitted to our insurance company.

**Play Ground Equipment:**

Adrian inspected the chains and said that they looked good to him, but our rocking snail was on its' last leg. Adrian was going to look into the cost of replacing the snail.

**Service Project Request:**

A church group of all ages was asking if there were any projects they could do – the volleyball court needs some regarding so this was what we were going to suggest to them. Also, the horticulture class at the High School would be a possibility for future projects.

## **New Business:**

### **Park Mowing:**

DGSA was wondering why their fields weren't being mowed. The contract we put out to bid states that they mow their fields from the beginning of the season until the second week of June. If they want to have our person do their part and bill them they can let us know and we can set that up. The cost is \$45. Lynn will let softball know.

### **Water Diversion**

This will be worked on when the path installation occurs.

### **Old Snack Bar**

Northern Softball (High School) has asked if they could have the old snack bar. If no one else in the park is going to be using it and the boro and township (who paid for it originally) don't care, LPA doesn't have a problem with it as long as they move it themselves. Jim will check with all the parties involved and see what happens.

### **Parking Along Soccer Field**

Signs need to be put up so that people don't park along the soccer field along the side of the park going down to the lower parking lot.

### **Signs for Soccer Field**

We need to put signs up along the soccer field stating that people should stay off of them when the field conditions are poor. This is to prevent damage to the fields. We need to check with the solicitor or police for the correct wordage so that it is enforceable if people are found to have done damage to the fields.
