**Meeting Administrative Issues**

*Meeting Called to Order:* Chairman Jim Hess called the meeting to order at 7:00 pm.

*Reading and Approval of the Minutes:* The Board reviewed the minutes of May 15th meeting. Approval of these minutes as well as from April were tabled pending a quorum.

*Treasurer's Report:* The Board reviewed the Treasurer's report provided by Adrian Piechowicz. He cited mowing and several miscellaneous bills as the primary activity of the Treasury during the past month. Approval of the Treasurer's Report was tabled pending a quorum.

**Visitors Presentation-** Stephanie Clough discussed her request to use a small grassy area below the volleyball court in the park for a program called Zumba Atomic-Zumba for children ages 4-12. The request is for every Friday for 1 hour until the middle of August. Stephanie is a certified Zumba Atomic instructor and CPR certified and will provide the authority with proof of insurance for use of the area. Jim discussed the program with all of the members and everyone was in agreement to allow Stephanie to proceed with this program every Friday for 1 hour held at the park.

Sean Malo requested to have a bench placed in the park as a memorial to a deceased friend. Adrian will get Sean the information about the benches that are currently in the park. If this agreeable, the placement and type of bench to be determined by LPA. Sean also discussed the possibility of a tree donation in the future.

**Old Business**

*2013 Project Prices:* The Kiwanis Club donated \$1,000.00 for new tables. The total cost of the new tables is \$2,312.00, with some labor required for assembly. The tables consist of a metal frame with wood seat and top. Everyone was in agreement to have Adrian move forward with this project and order them.

*Tree limbs to be removed:* Jim checked on this tree in question and presented to the board that the dead limbs are in fact hanging into a resident's yard. These limbs are high and Jim will get a price on having the limbs cut down. In addition 2 smaller dead trees have been identified and Jim will have a price quote to include removal of these as well.

*Wetlands:* Steve Alves has attempted to find out more information about the previously identified wetland area by contacting Chris Pecora-engineer. He has not heard back from him.

**New Business**

Nancy Putt inquired if Mr. Gayman from the Dillsburg Borough would spray for weeds around the gravel areas. Holly agreed to ask him to do this.

The ground level bulb and glass light which illuminated the flag was vandalized. Jim will get a price on the cost to replace.
