**National Night Out**

National Night Out was a great success. Hundreds of people were in attendance and several members of LPA were there to hand out surveys. A total of 85 were gathered and the results were favorable. A compilation will be put out in the Carroll Township and Dillsburg Borough newsletters. Sam wrote a letter to the editor of the Dillsburg Banner about the dedication of the barn in the park. This was to have taken place during National Night Out, but due to the large crowd it wasn't possible to have everyone gather at the barn and be able to be heard. The letter was well written and having such a large crowd was a good thing for a problem.

**175<sup>th</sup> celebration**

A schedule was handed out and everyone signed up to help cover the two booths. Lynn has prizes for the game booth. Terri was taking care of getting the bags for the mugs. Tom will make sure we have money for change. Bob will make sure we have a cashbox. Lynn is bringing a 10 x 10 tent and Sam will bring large canopy.

**Barn Update**

The bathrooms had not been cleaned yet. A rough job description was written up and it was decided that one cleaning a week and one re-stocking a week when the park is in normal use is what we are asking. Several people on the Authority thought they had someone they knew that would be interested. Everyone was told to contact someone and find out how much they would do it for.

Soccer would like to start using the upstairs room to meet. They offered to buy several cafeteria style tables and chairs for that room that they are getting from a clearance sale.

**Park Gate**

Discussion was had to install a new security gate before finishing the kitchen. It was decided to rough in the whole area but to only finish the concession stand part. Once that is done, the gate should be a bigger priority than the kitchen area. Depending on funds at that time, LPA may have to ask Dillsburg Boro for an additional amount of park and recreation money.

**Discussion of Proposed Development Across from the Park**

The Carroll Township Supervisors have filed an appeal of the ruling to allow the development to proceed across the street from the park as originally submitted.

### **Moving Leftover Beams From the Park**

Sam requested help moving the leftover beams from the barn construction to the tavern. Bob said he would be able to take care of that, and several people said to let them know and they would also help.

### **Old or New Business**

The request for funds from Dillsburg Borough is due this month. Tom will put together the request and forward it to Borough Council.

The grant is moving forward with both Dillsburg and Carroll Township providing work towards the plan. An updated site plan was required to be submitted with the new playground and the barn structure. Also, as this grant was for a walking path and a playground, we will have to add some things to the playground to satisfy the requirements since we went ahead and did the playground with money from Carroll Township.
