Walking Path:

Logan Park Appointments:

Election of Officers:

Election of Logan Park Authority Officers will take place in January.

Closing of Restrooms for the Season:

Due to the warm weather the park is still being used heavily. It was decided to let the bathrooms open through November. The cleaning woman comes on Fridays or Saturdays. After she comes on Friday, December 4th they will pull the power to the locks so they are disabled. The Carroll Township road crew will take care of draining the lines the following week.

Public Field Usage Liability Rules

Once again, there have been young adults found playing football on the upper soccer field when it was completely saturated and tearing it up. When asked to leave they became belligerent and obnoxious. With no rules posted, there is nothing anyone can do.

We need to determine what laws are being broken and what signs need to be posted in order to hold people responsible for the damage they do. Even though it is "just grass", thousands of dollars are spent each year on that grass.

Please note that the Authority has no problem with people playing on those fields when the ground is in the proper condition. However, when the ground is saturated or in poor condition, it cannot be torn up further.
